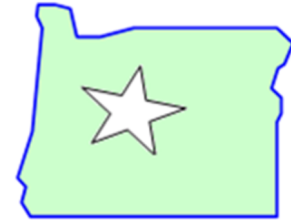

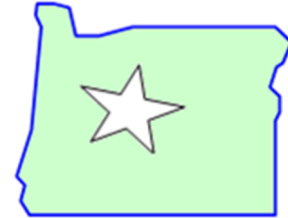

Motion to postpone Chapter Officer vote originally scheduled for ABM in November of each year. Motion passed. Any nominations email to Todd & Aaron.

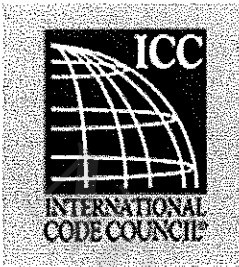

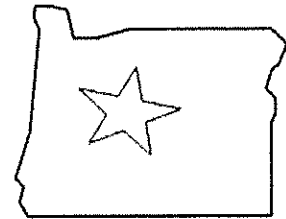
ICC awards presented, Veteran Outreach Award presented for Tim Heck for his work and dedication to Building Codes, the community, and his work with our Military Veterans.
