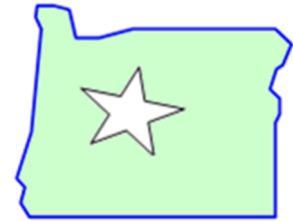

-Bring a permit tech to meetings.

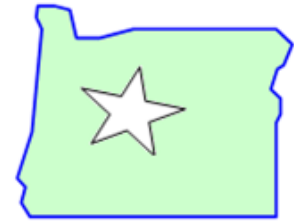
